Jefferson County Rural Library District Board of Trustees 2022 Budget Workshop Meeting Location: Online, via Zoom.us Minutes – Wednesday, September 29, 2021

Twelve library staff members will be receiving scheduled 3% step increases. Total salary and benefits expenditures are expected to increase approximately 8.6% in 2022 due to added positions and increases in benefit premiums.

**Operating Expenditures - review spreadsheets by BARS category:** Tamara Meredith and the Board reviewed the projected operating expenses for 2022.

Materials - review spreadsheets by BARS category: Tamara Meredith and the Board reviewed the proposed budget for materials expenses for 2022.

**Capital - review spreadsheets by BARS category:** Tamara Meredith reviewed the proposed draft budgets for Capital expenditures in 2022.

Chapman reported that property values will continue to rise, and he gave an overview of TAV and DNR revenues. He also shared the library's current levy rate of \$.38 per \$1,000.00 and answered questions about the levy lid lift process.
